

## Terms and Conditions of CapitaCard Capita\$ Rebate on Supermarket Purchases

- 1) CapitaCard Capita\$ Cash Rebate on supermarket purchases is only valid for CapitaCard Visa Platinum Credit Cardmembers (“Cardmember”).
- 2) Additional 2.7% Capita\$ Cash Rebate (“Rebate”) on supermarket purchases at participating CapitaMalls will be credited on top of the usual 0.3% Capita\$ Cash Rebate.
- 3) To enjoy the Rebate, Cardmember must charge a minimum of S\$800 to a CapitaCard Visa Platinum Credit Card in each calendar month based on posting date.
- 4) The combined spend is calculated based on posted local and foreign retail sales (including supermarket purchases at participating CapitaMalls), posted 0% interest-free installment plan, posted recurring bill payment and excludes Internet purchases, interest, finance charges, cash withdrawal, balance transfer, smart cash and all fees charged by DBS Bank Ltd (“DBS”).
- 5) The following is the list of supermarkets in participating CapitaMalls:

- 6) Supermarket purchases at participating CapitaMalls made must be posted transactions before the end of each qualifying quarter (“Quarter”). DBS accepts no liability for any late submission of the purchases by merchants.
- 7) The qualifying Quarters are as follows:

Qualifying Quarter	Qualifying period per Quarter
1 <sup>st</sup> Quarter	Between 1 Nov and 31 Jan
2 <sup>nd</sup> Quarter	Between 1 Feb and 30 Apr
3 <sup>rd</sup> Quarter	Between 1 May and 31 Jul
4 <sup>th</sup> Quarter	Between 1 Aug and 31 Oct

- 8) The Rebate will be credited into the Cardmember’s CapitaCard Visa Platinum Credit card within one month after the end of each Quarter.
- 9) The Rebate awarded will be limited to Capita\$8.10 per card per calendar month. Total Rebate awarded per Quarter will be limited to Capita\$24.30 per card.
- 10) The CapitaCard Visa Platinum Credit card account (“Account”) must be in good standing at the time of crediting of the Rebate. In the event the Account is delinquent, terminated or suspended for any reason whatsoever before the Rebates are credited into the said Account, DBS reserves the right to forfeit the Rebate at its sole discretion.
- 11) DBS may vary the terms of or withdraw the Rebate programme without prior notice.
